Topic: FHA and VA Loan Limit Increase for 2019

FHA

Per FHA ML 2018-11, effective with case numbers assigned on or after January 1, 2019, PennyMac is aligning with FHA's increase to the floor and ceiling loan amounts. Complete details of FHA loan limits can be found at http://www.hud.gov/pub/chums/file_layouts.html.

VA

For all non-IRRRL VA loans, effective with loans closed on or after January 1, 2019, PennyMac is aligning with VA's increase to the county loan limits. VA does not have a maximum loan amount, but instead uses the county loan limit to determine the maximum potential entitlement available. Complete details of VA's county loan limits can be found at https://www.benefits.va.gov/homeloans/purchaseco_loan_limits.asp.

As a reminder, PennyMac requires that all VA loans conform to GNMA secondary market guidelines which include the minimum 25% coverage requirement.
